Dear FOIA Officer

Pursuant to the Freedom of Information Act, 5 U.S.C. §552 et seq. (“FOIA”), I am requesting access to the following public records:

- Any paper or electronic correspondence, including attachments, exchanged between the Southwestern Power Administration (hereinafter known as "your agency") and Edward W. Gillespie, commonly known as Ed Gillespie, in his capacity as a lobbyist for Enron Corporation from 1/1/1999 to 12/31/2002. We are providing these addresses to assist in your search, and request that you *not* limit your search to only these addresses.
- Any paper or electronic correspondence, including attachments, exchanged between your agency and the following lobbyists for Enron from the firm of Quinn Gillespie: Edward.gillespie@gmail.com, egillespie@qga.com, ed@quinngillespie.com, egillespie@quinngillespie.com, gillespie@quinngillespie.com, ed@edgillespiestrategies.com. This request covers 1/1/1999 to 12/31/2002
- Record of any meetings held between staff at your agency and Edward W. “Ed” Gillespie, Maria Zometsky, Bruce Andrews, Dave Lugar, Loren Raszick, Ashley Meece, or John M. Quinn from 1/1/1999 to 12/31/2002.

If this request is denied in whole or in part, I ask that you cite in writing the specific statutory exemption upon which you have relied. I also ask that you provide non-exempt portions of otherwise exempt documents.

I am willing to pay up to \$50 for your office to fulfill this request. If the cost of fulfilling this request will exceed that amount, I request that you provide me with a written cost estimate by e-mail at kendallva2017@gmail.com prior to incurring any costs.

My preferred reproduction format is an electronic file e-mailed to me at kendallva2017@gmail.com. If this is not possible, I request that you provide access to these records electronically via an FTP site, or mail electronic copies of the records to me on removable media, such as a CD or flash drive. If none of these delivery methods are feasible, I request that you mail paper copies of the records to me at the address provided above.
