This is the final response to the request for information that you sent to Southwestern Power Administration (SWPA) under the Freedom of Information Act (FOIA) 5 U.S.C. 552. You requested:

All correspondence between the head of Southwestern Power Administration and Ricky Perry and the following members of his staff; Brandy Marty, Brian Newby, Jay Kimbrough and Ray Sullivan between January 1, 2012 and until the date this request is filled.

Your request was assigned to SWPA's Administrator to conduct a search of his files for responsive records. Also an electronic search was completed. The search was completed and no documents were found.

This decision, as well as the adequacy of the search, may be appealed within 90 calendar days from your receipt of this letter pursuant to 10 C.F.R. 1004.8. Appeals should be addressed to Director, Office of Hearings and Appeals, HG-1, L'Enfant Plaza, U. S. Department of Energy, 1000 Independence Avenue, S.W., Washington, D.C. 20585-1615. The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal to OHA.filings@hq.doe.gov, including the phrase, "Freedom of Information Appeal" in the subject line. The appeal must contain all of the elements required by 10 C.F.R. 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either: 1) in the district where you reside; 2) where

you have your principal place of business; 3) where DOE's records are situated; or 4) in the District of Columbia.


